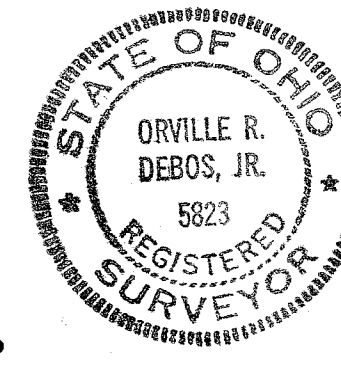

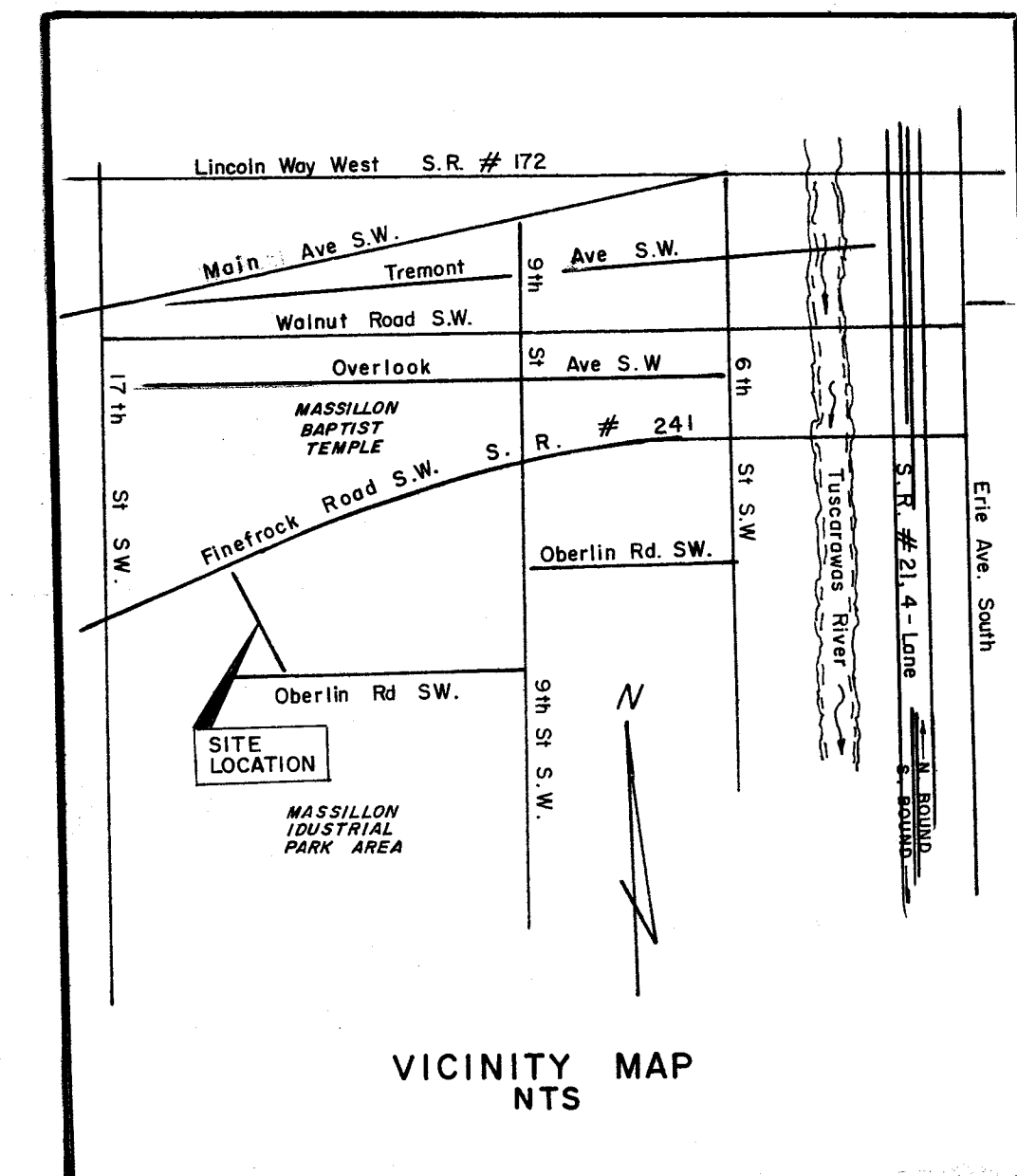

BASIS OF BEARING :

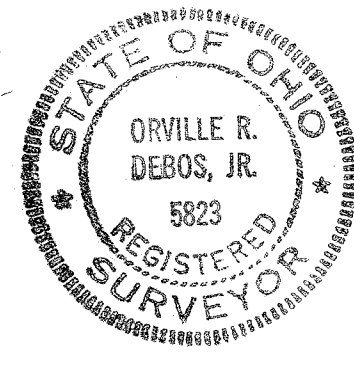
