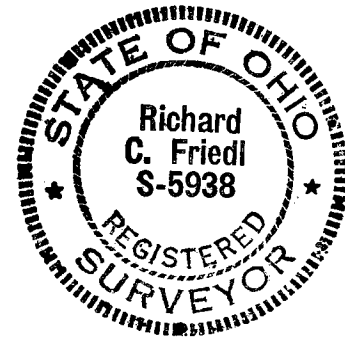


REPLAT OF LOTS 15603 AND 15604

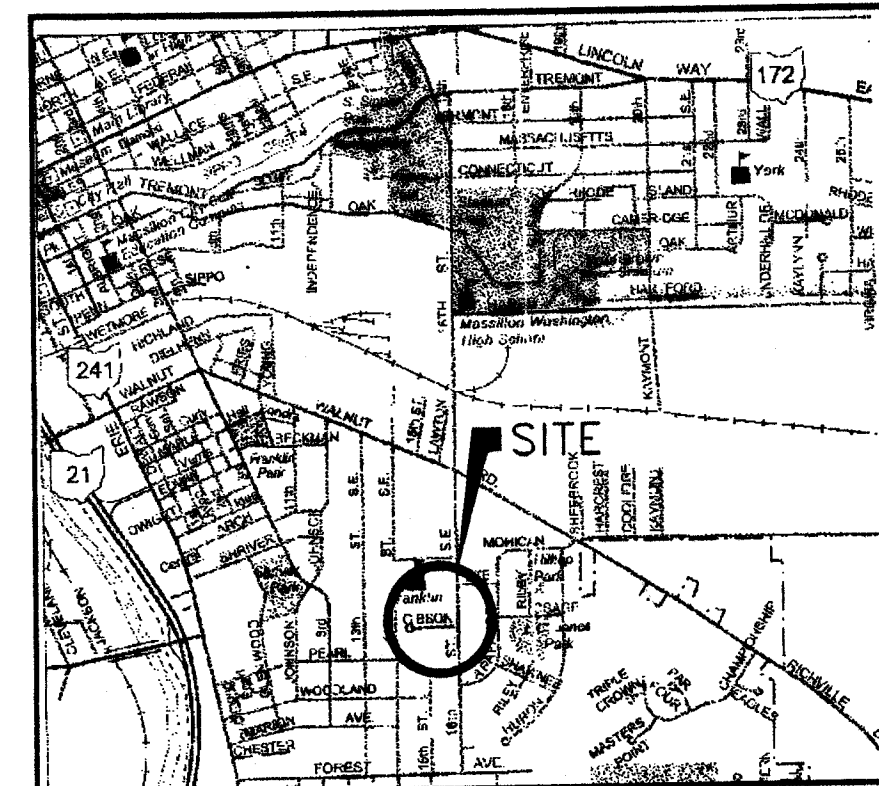

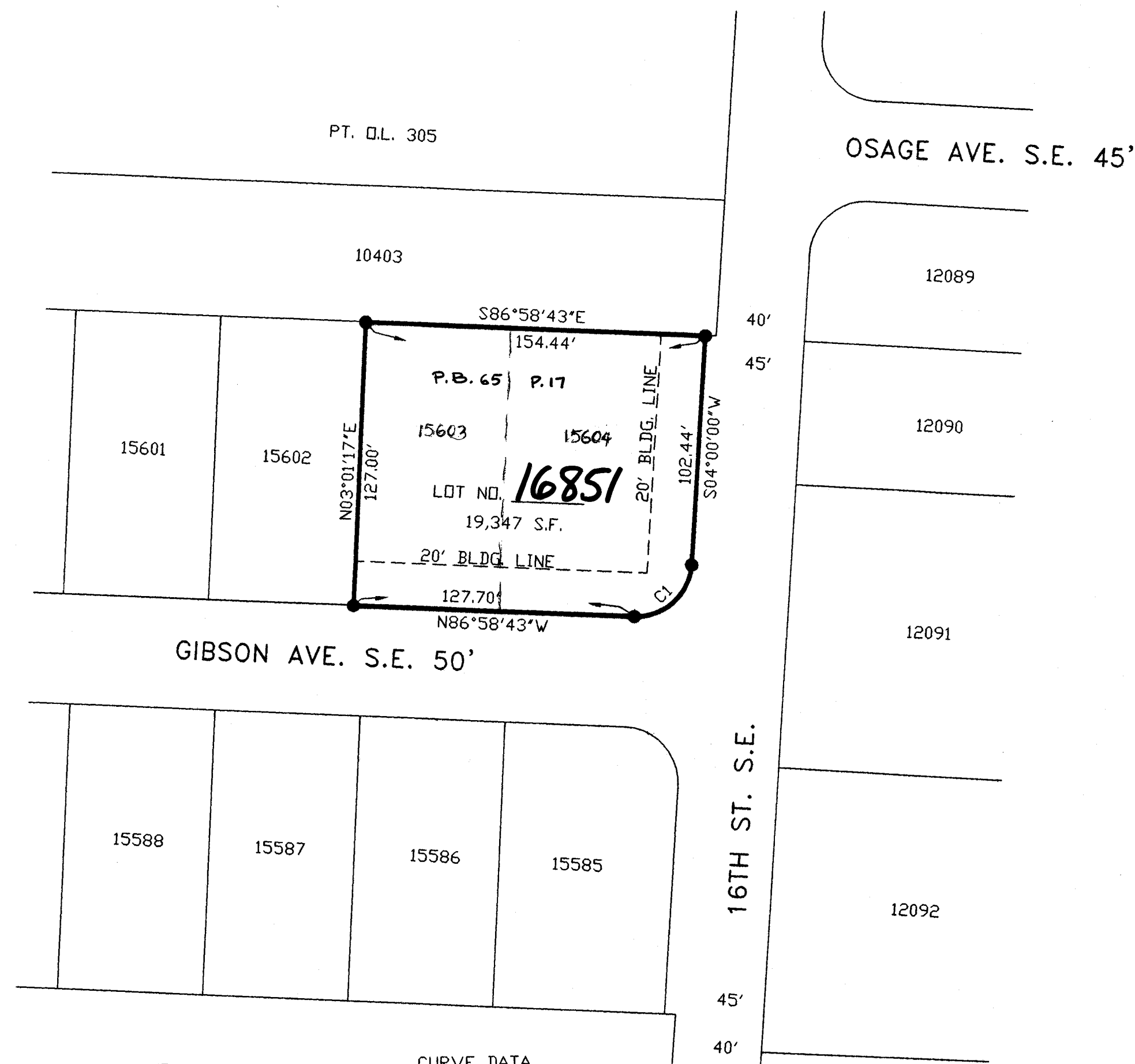
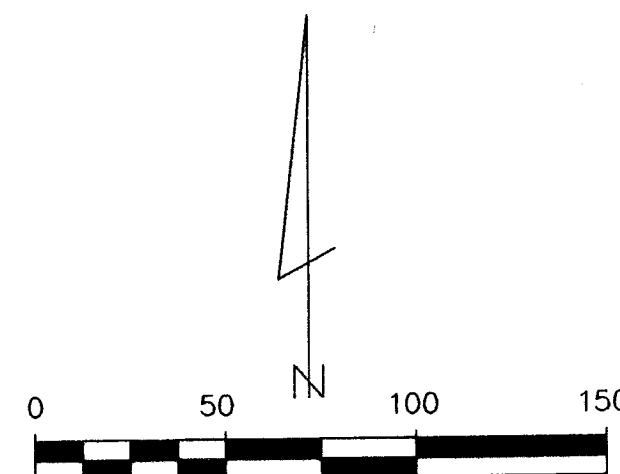
