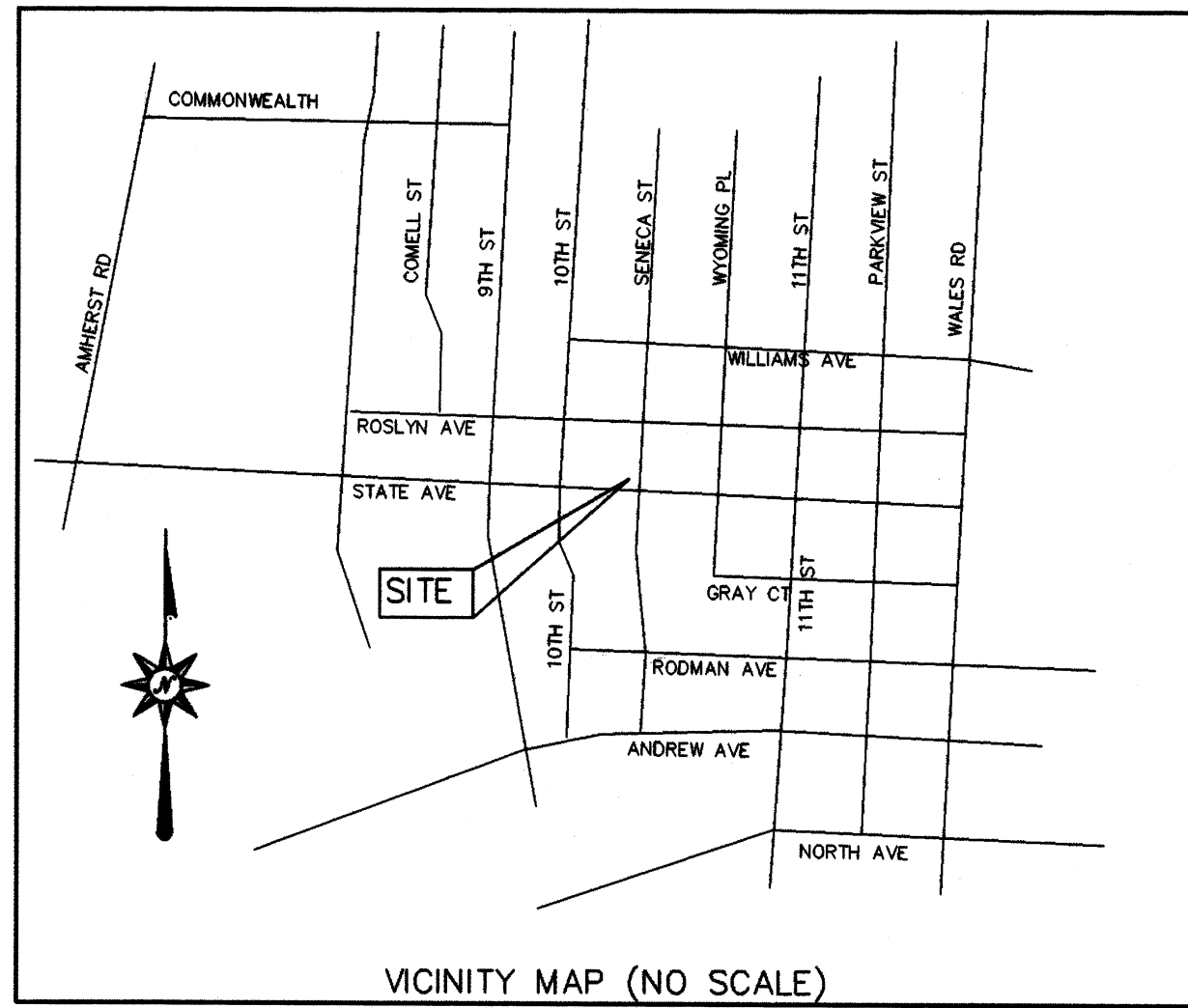

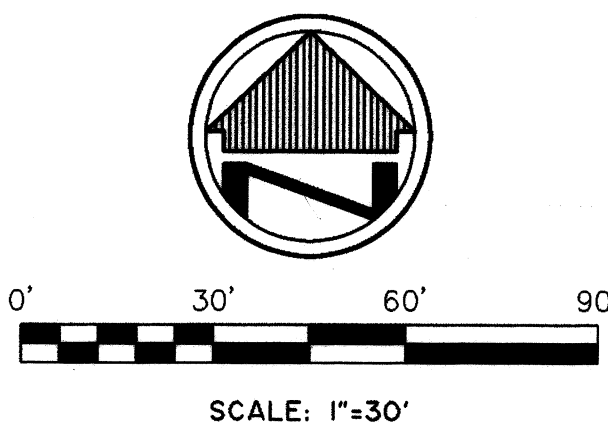
1. TAX MAP: MASSILLON CITY 24 AND 14

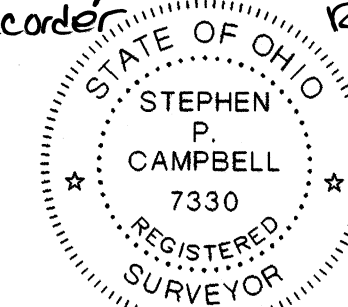
