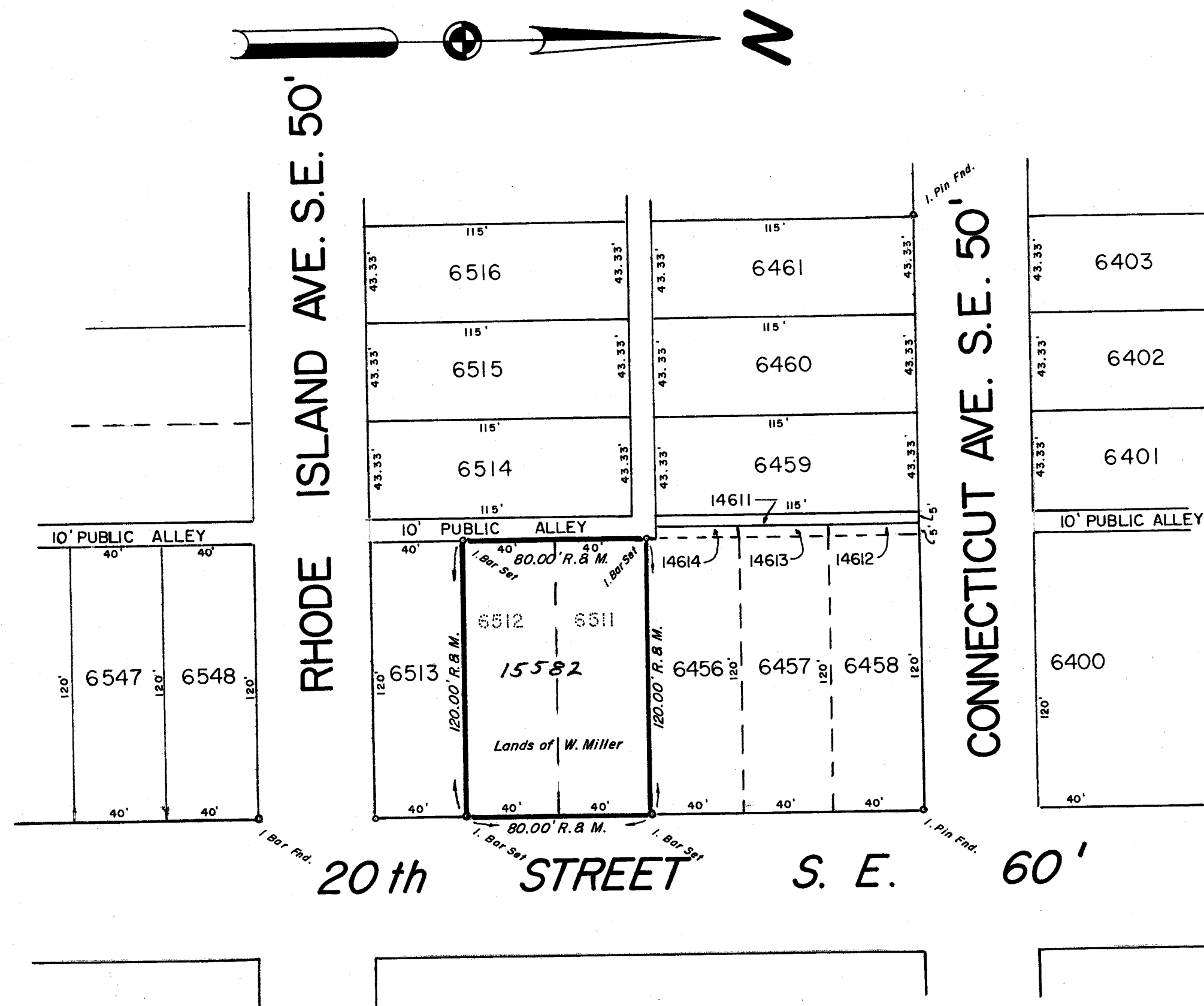




REPLAT OF

Lot Numbers 6511 & 6512 in the City of Massillon, County of Stark, Ohio.

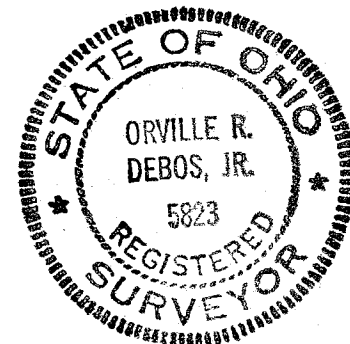
