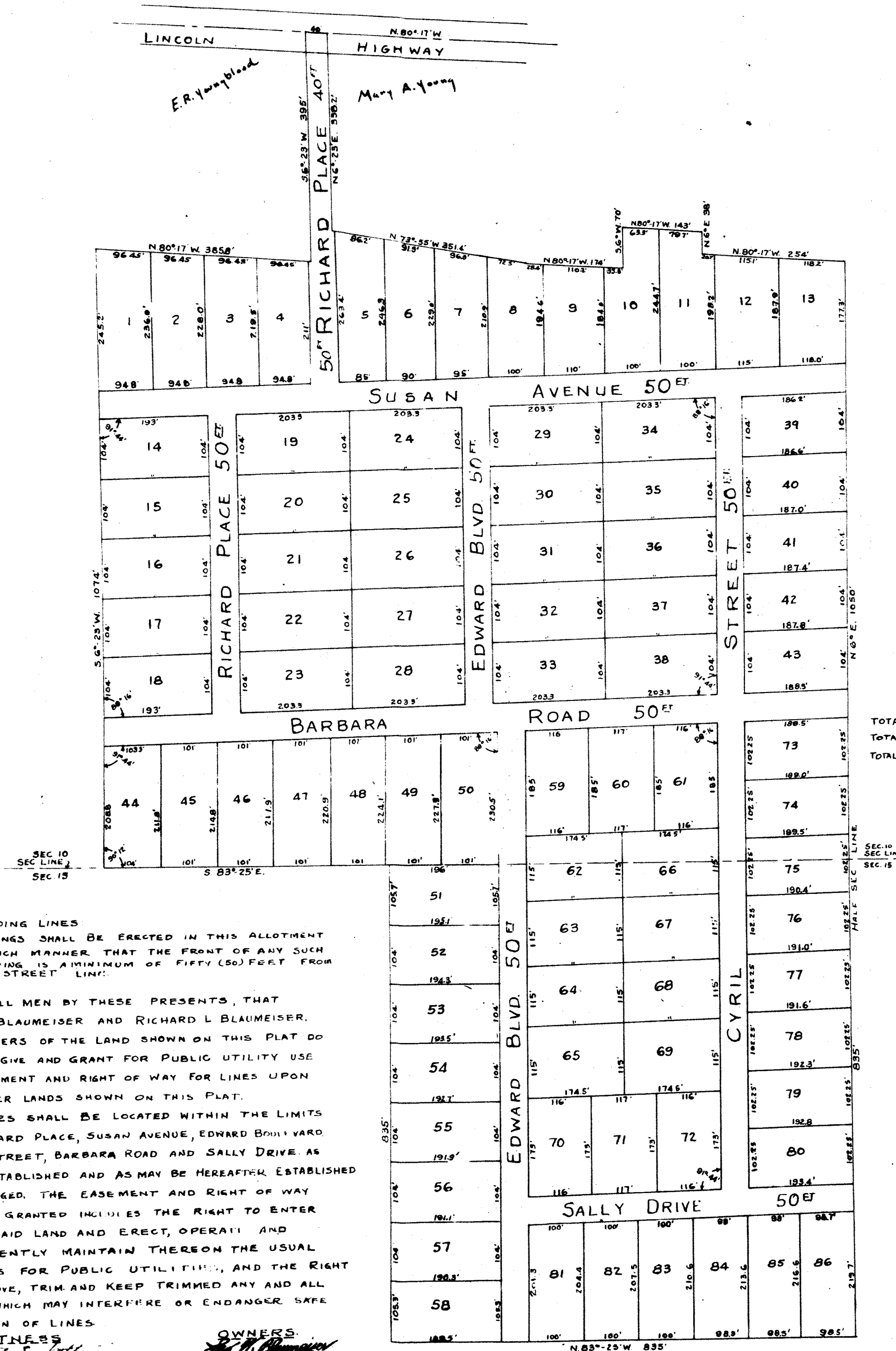




BUILDING LINES
BUILDINGS SHALL BE ERECTED IN THIS ALLOTMENT
IN SUCH MANNER THAT THE FRONT OF ANY SUCH
BUILDING IS A MINIMUM OF FIFTY (50) FEET FROM
THE STREET LINE.

KNOW ALL MEN BY THESE PRESENTS, THAT
LEO W. BLAUMEISER AND RICHARD L. BLAUMEISER,
THE OWNERS OF THE LAND SHOWN ON THIS PLAT DO
HEREBY GIVE AND GRANT FOR PUBLIC UTILITY USE
AN EASEMENT AND RIGHT OF WAY FOR LINES UPON
AND OVER LANDS SHOWN ON THIS PLAT.
THE POLES SHALL BE LOCATED WITHIN THE LIMITS
OF RICHARD PLACE, SUSAN AVENUE, EDWARD BLVD.
CYRIL STREET, BARBARA ROAD AND SALLY DRIVE AS
NOW ESTABLISHED AND AS MAY BE HEREAFTER ESTABLISHED
OR CHANGED. THE EASEMENT AND RIGHT OF WAY
HEREIN GRANTED INCLUDES THE RIGHT TO ENTER
UPON SAID LAND AND ERECT, OPERATE AND
PERMANENTLY MAINTAIN THEREON THE USUAL
FIXTURES FOR PUBLIC UTILITIES, AND THE RIGHT
TO REMOVE, TRIM AND KEEP TRIMMED ANY AND ALL
TREES WHICH MAY INTERFERE OR ENDANGER SAFE
OPERATION OF LINES.
