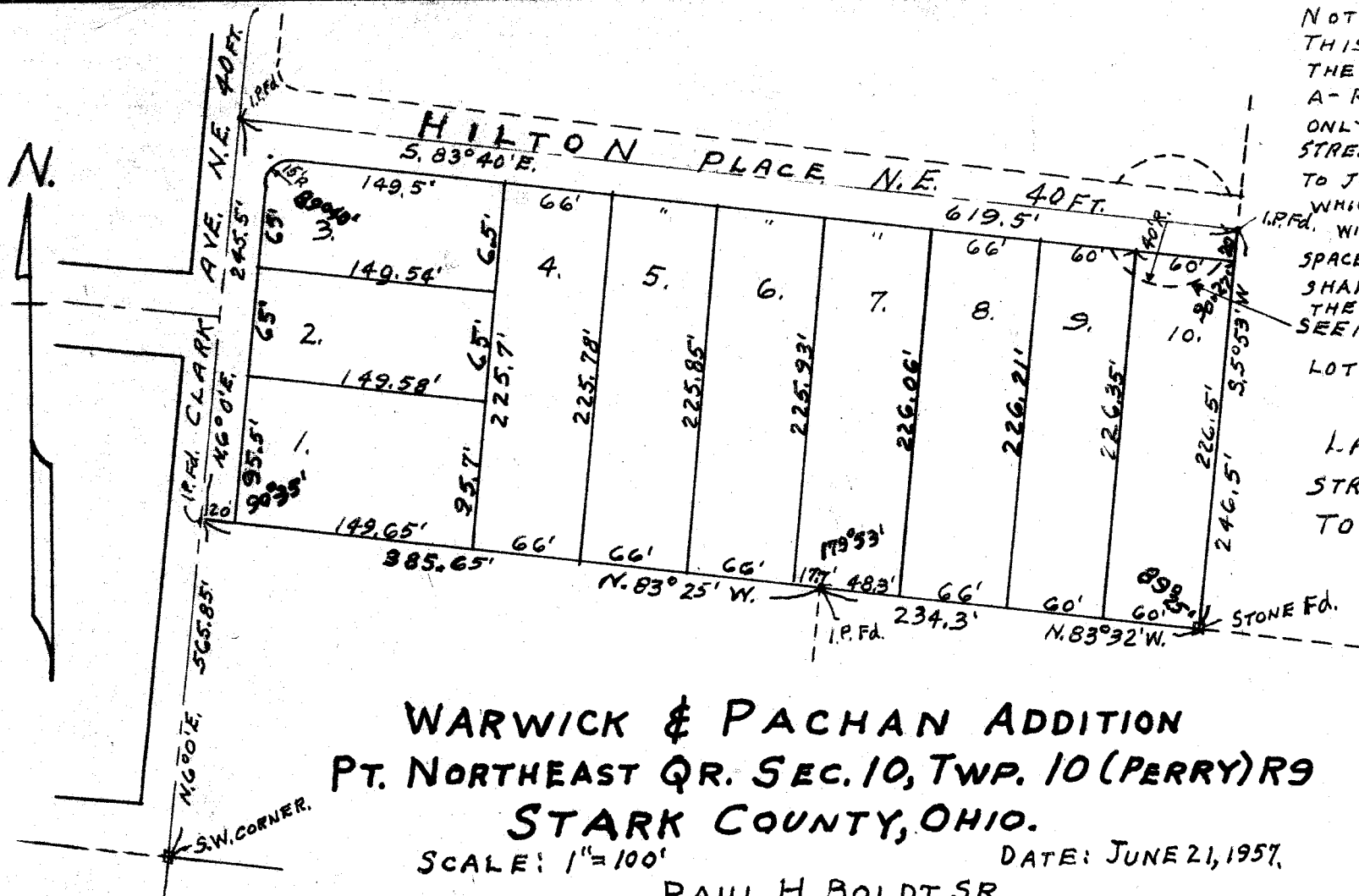




NOTE "A"
THIS EASEMENT IS INTENDED FOR THE PURPOSE OF A TEMPORARY TURN-A-ROUND, FOR USE BY THE PUBLIC ONLY UNTILL SUCH TIME AS LYNCH STREET IS EXTENDED EASTWARDLY TO JOIN WITH OTHER PUBLIC STREETS WHICH WILL ALLOW PROPER EGRESS I.P.F.D. WITHOUT THE NEED FOR "TURN-A-ROUND" SPACE. AT SUCH TIME THIS EASEMENT SHALL AUTOMATICALLY EXPIRE AND THE AREAS INVOLVED SHALL REVERT SEE NOTE "A" TO CONTROL OF ABUTTING LOT OWNERS.
