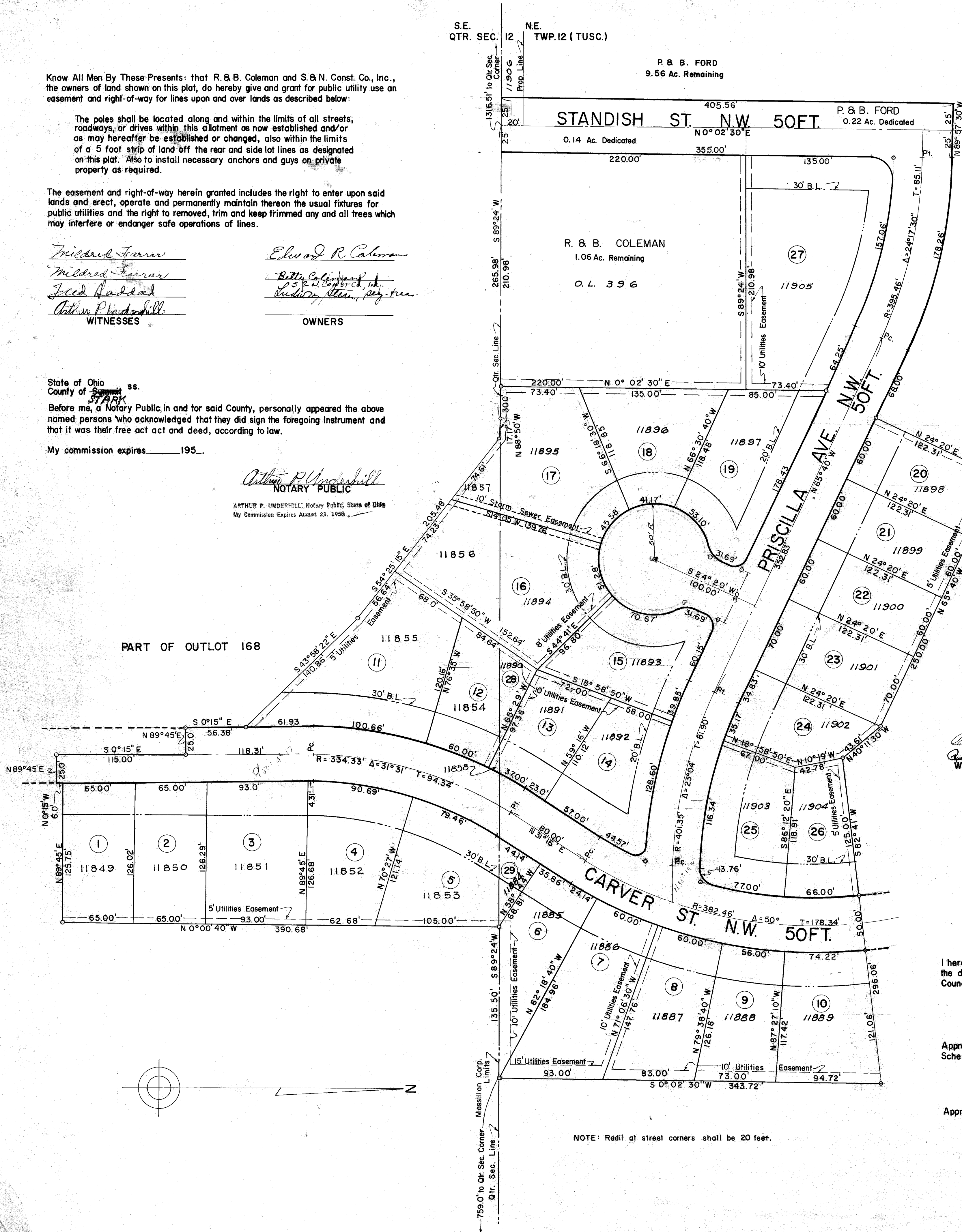

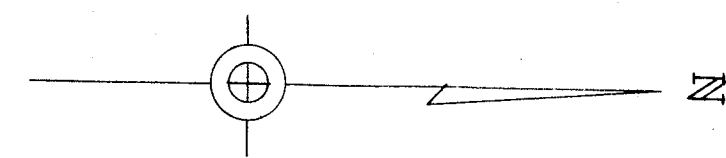

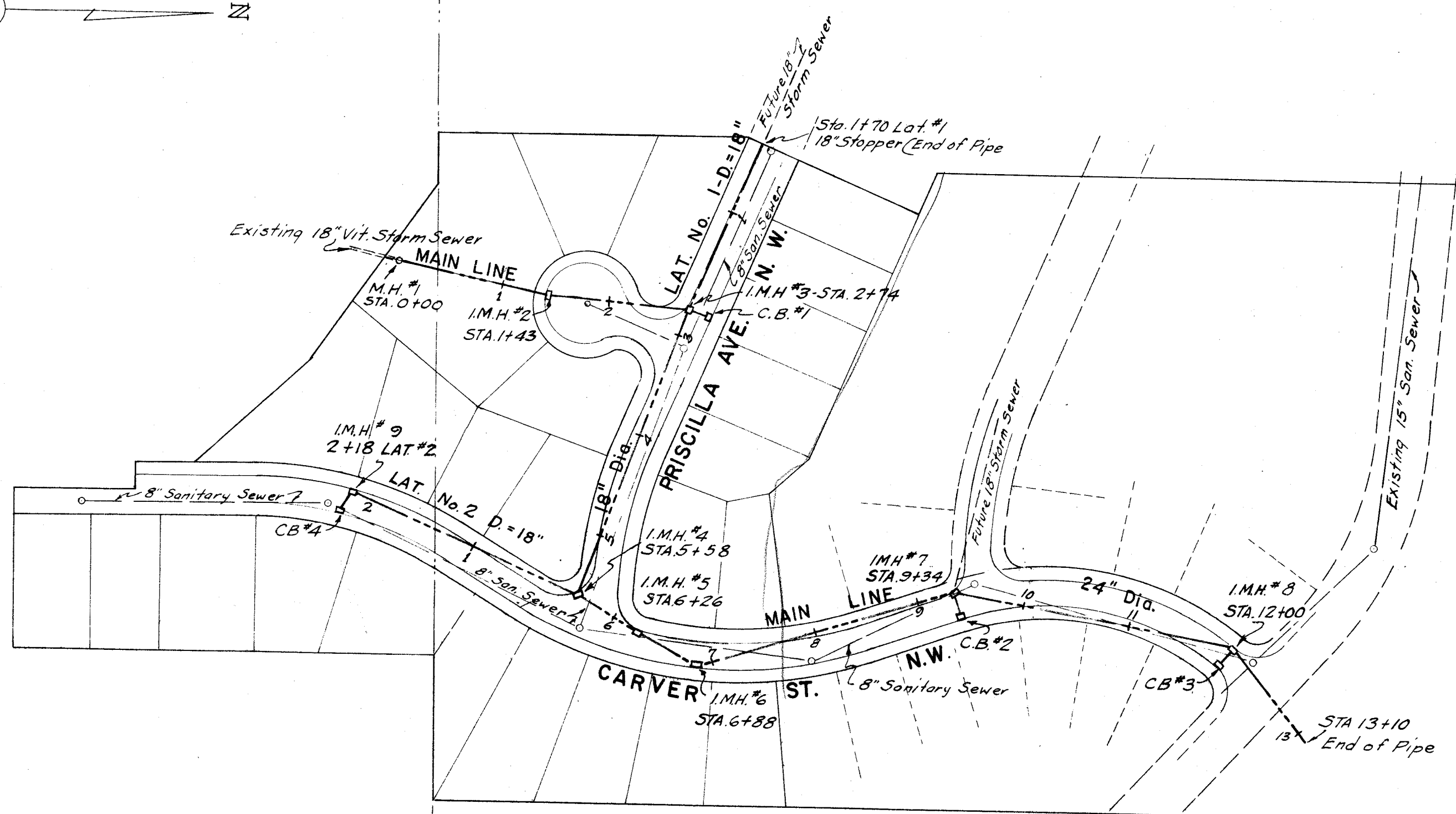
MAYFLOWER VILLAGE ALLOTMENT No. 4

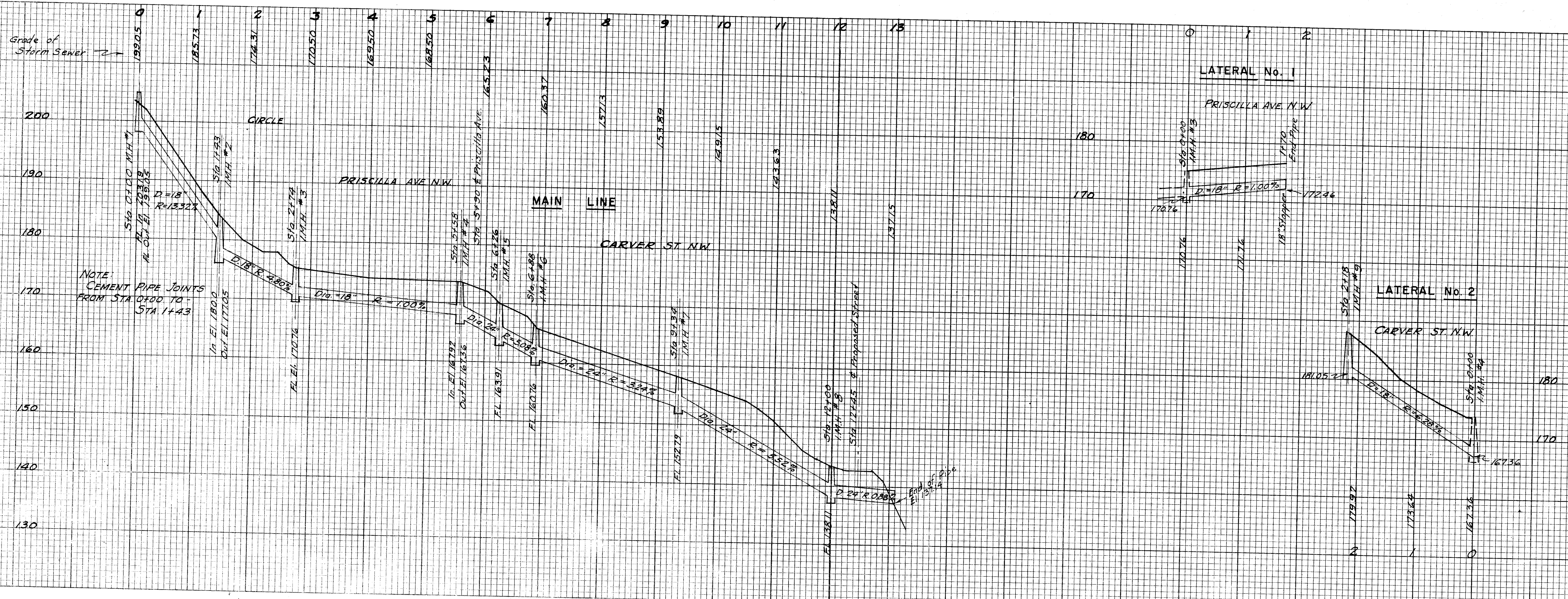
