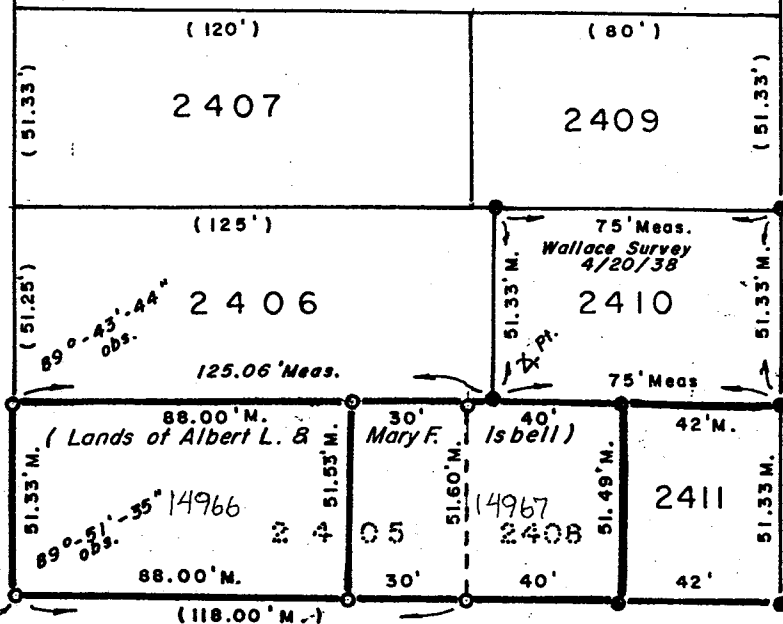
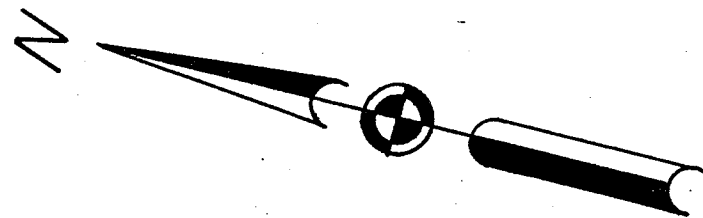


MAPLE AVE. S.E. 58'



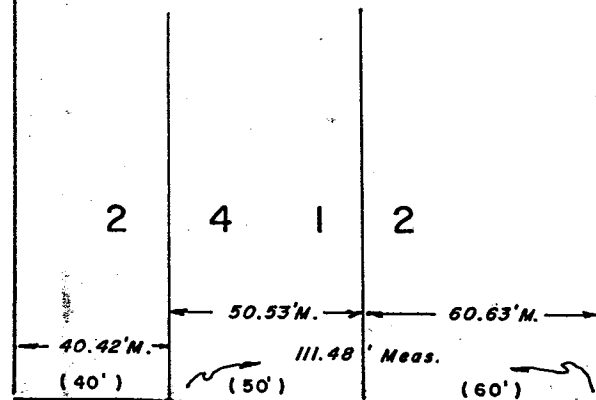

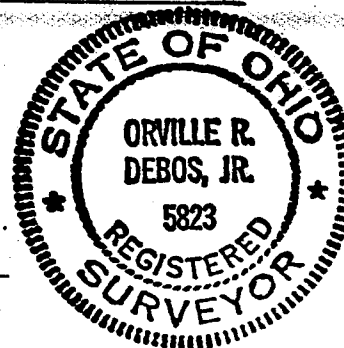

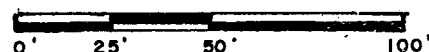
