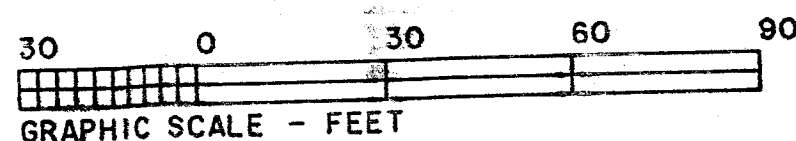


REPLAT OF LOTS 1340 & 1344 in the City of Massillon, Stark County, Ohio.

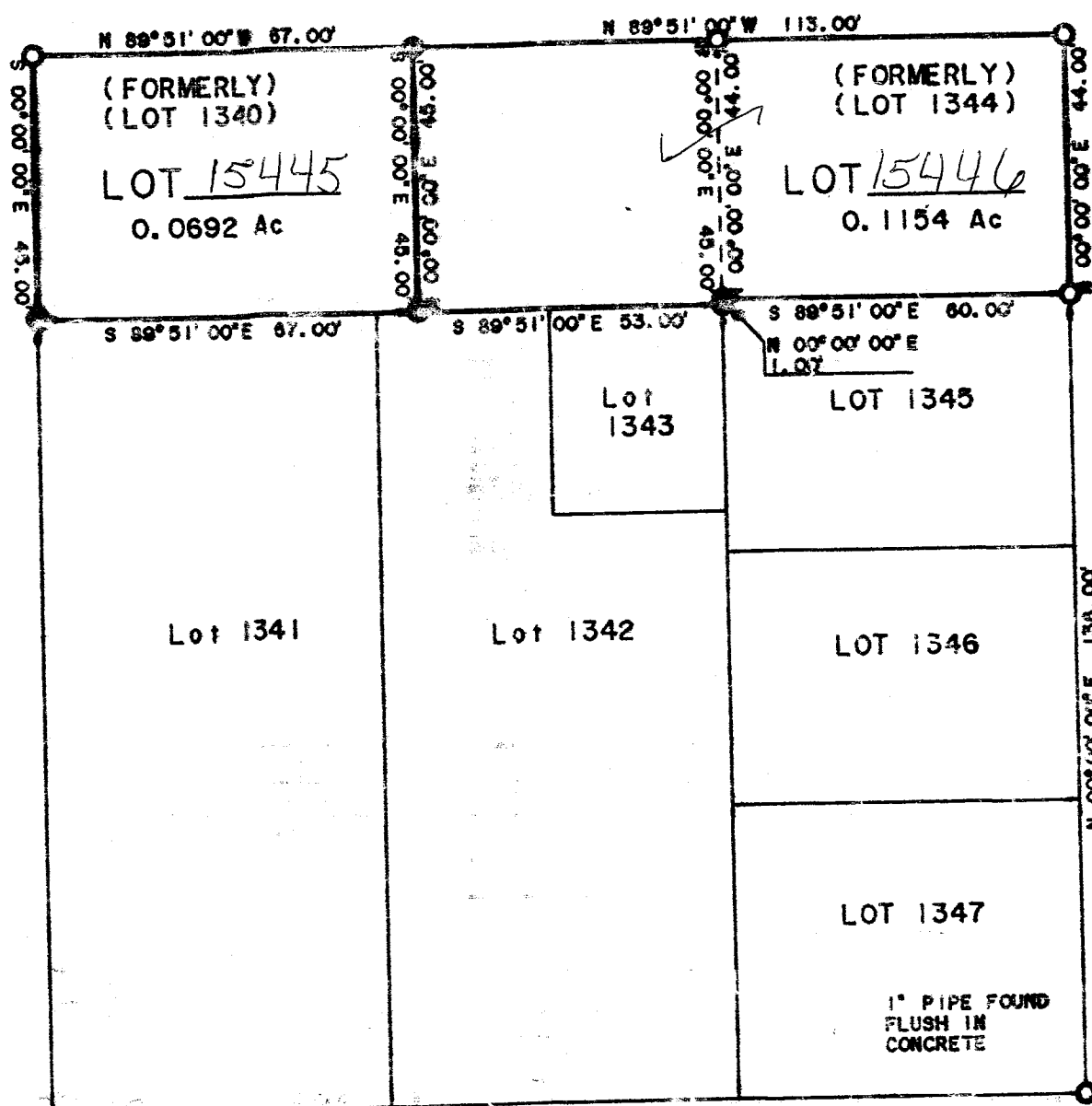

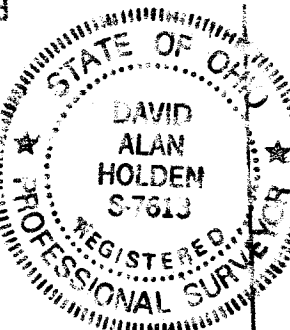
