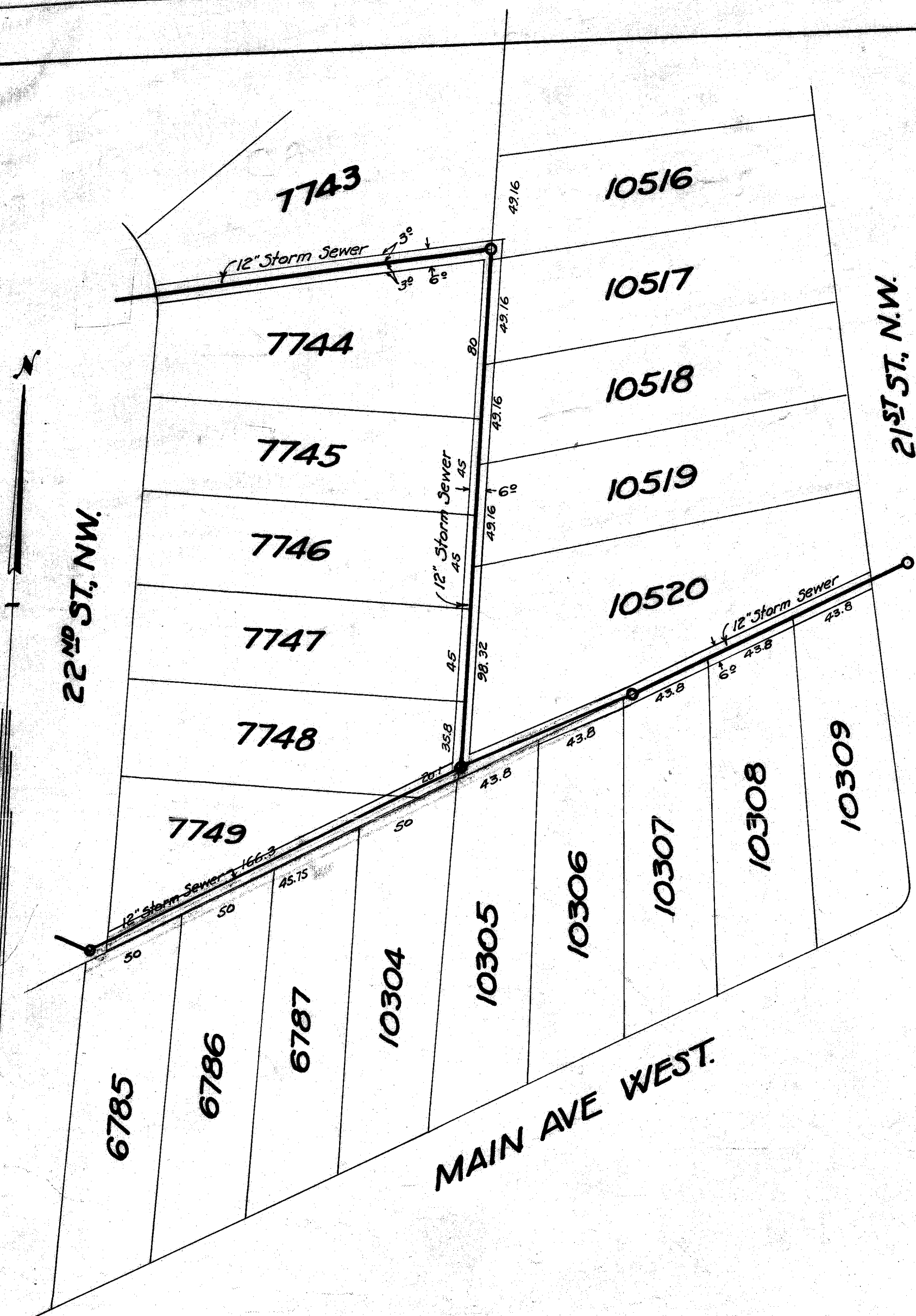

GRANT

We, the undersigned owners of the land hereon shown, for the sum of One Dollar and other considerations, receipt of which is hereby acknowledged, does hereby grant and convey to the City of Massillon, Ohio and its successors, the right to construct and forever maintain in and on said land, a storm sewer of inside diameter, with appurtenances as shown on this plat, to be situated with in a strip of land six (6) ft wide and with center line as shown hereon. Further, that the city and its agents may have the temporary use for construction purposes of an additional strip of land fifteen (15) feet wide and center line same as above, along above mentioned easement.
