The undersigned, owner of lands hereon shown, for the consideration of One Dollar and other considerations, receipt of which is hereby acknowledged, does hereby grant and convey to the City of Massillon, Ohio, and its successors, the right to construct and forever maintain, in and on said lands, a sanitary sewer of forty-eight (48) inches inside diameter, to be situated within a strip of land six(6) feet wide, and with center-line as shown hereon.

Further, that the city and its agents may have the temporary use for construction purposes, of an additional strip of land forty feet wide and parallel to and adjoining the easement aforesaid, where required, beyond toe of embankment.


