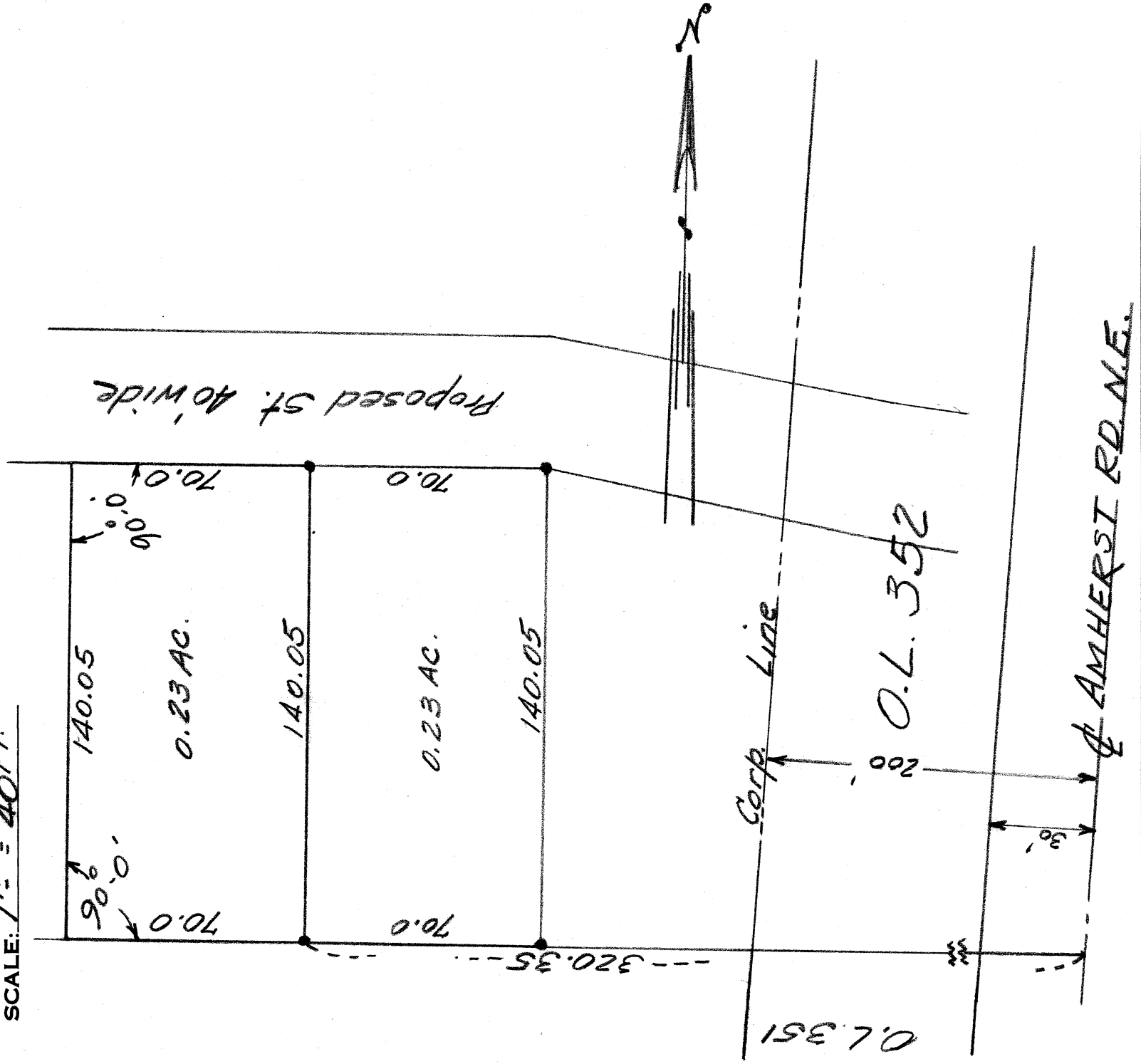

Known as a Part of the N.W. Quarter Section 5, Perry Township, Stark County, Ohio and being more fully described as follows:

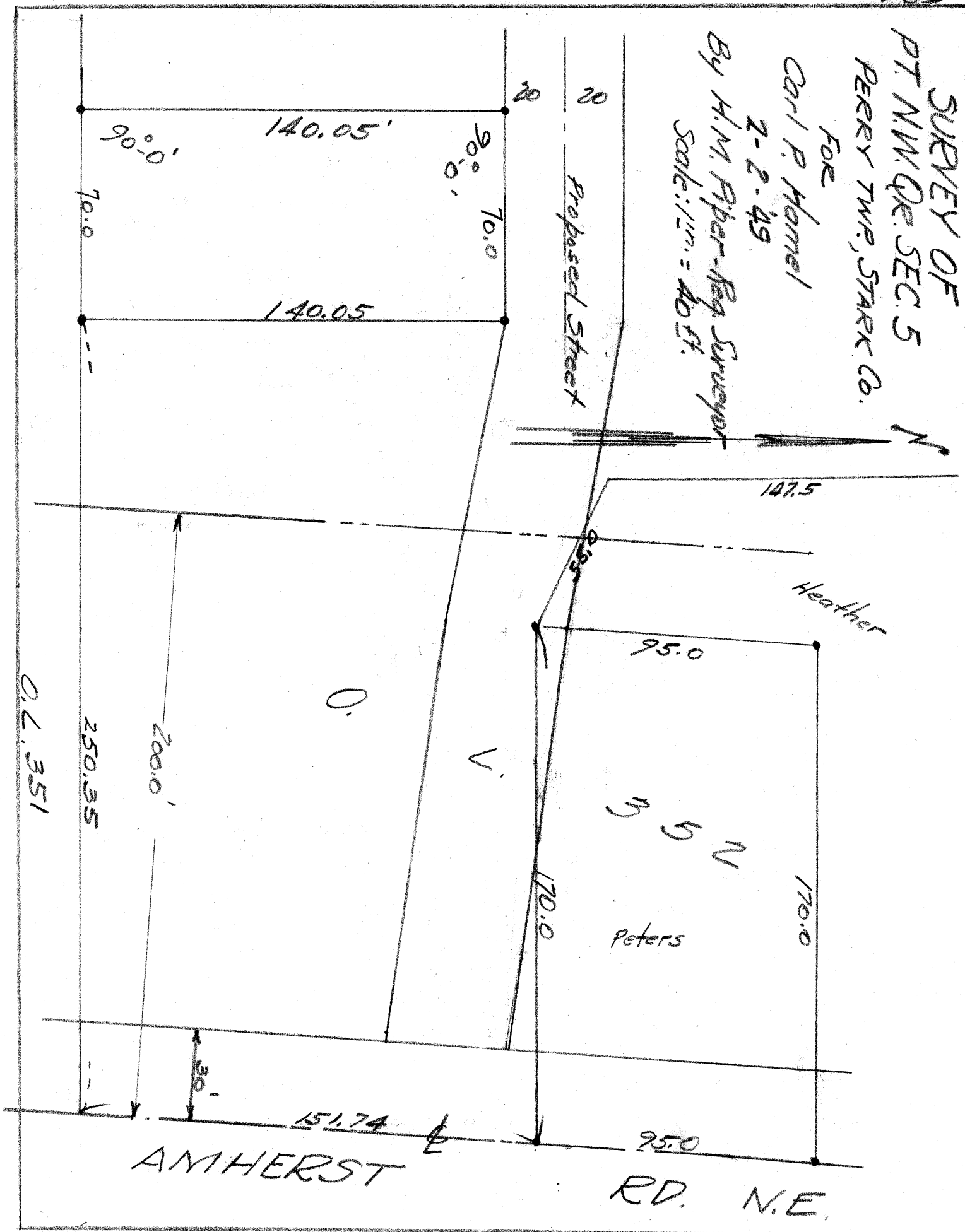

E., thence westerly along the south line of O.L. 352 extended 320.35 feet to a stake; thence continuing westerly along the south line of O.L. 352 extended 70.0 feet to a point; thence northerly at right angles to said line a distance of 140.05 feet to the south line of a proposed street; thence easterly parallel to the south line of O.L. 352 70.0 feet to a stake, said point also being on the south line of a proposed street; thence southerly 140.05 feet to the place of beginning containing 0.23 acres.

L. 352 250.35 feet to a stake, said point being the true place of beginning of the tract here in to be conveyed; thence continuing along the South line of O. L. 352 extended westerly a distance of 70.0 feet to a stake; thence northerly at right angles to said line a distance of 140.05 feet to a stake on the South line of a proposed street; thence easterly parallel to the South line of O. 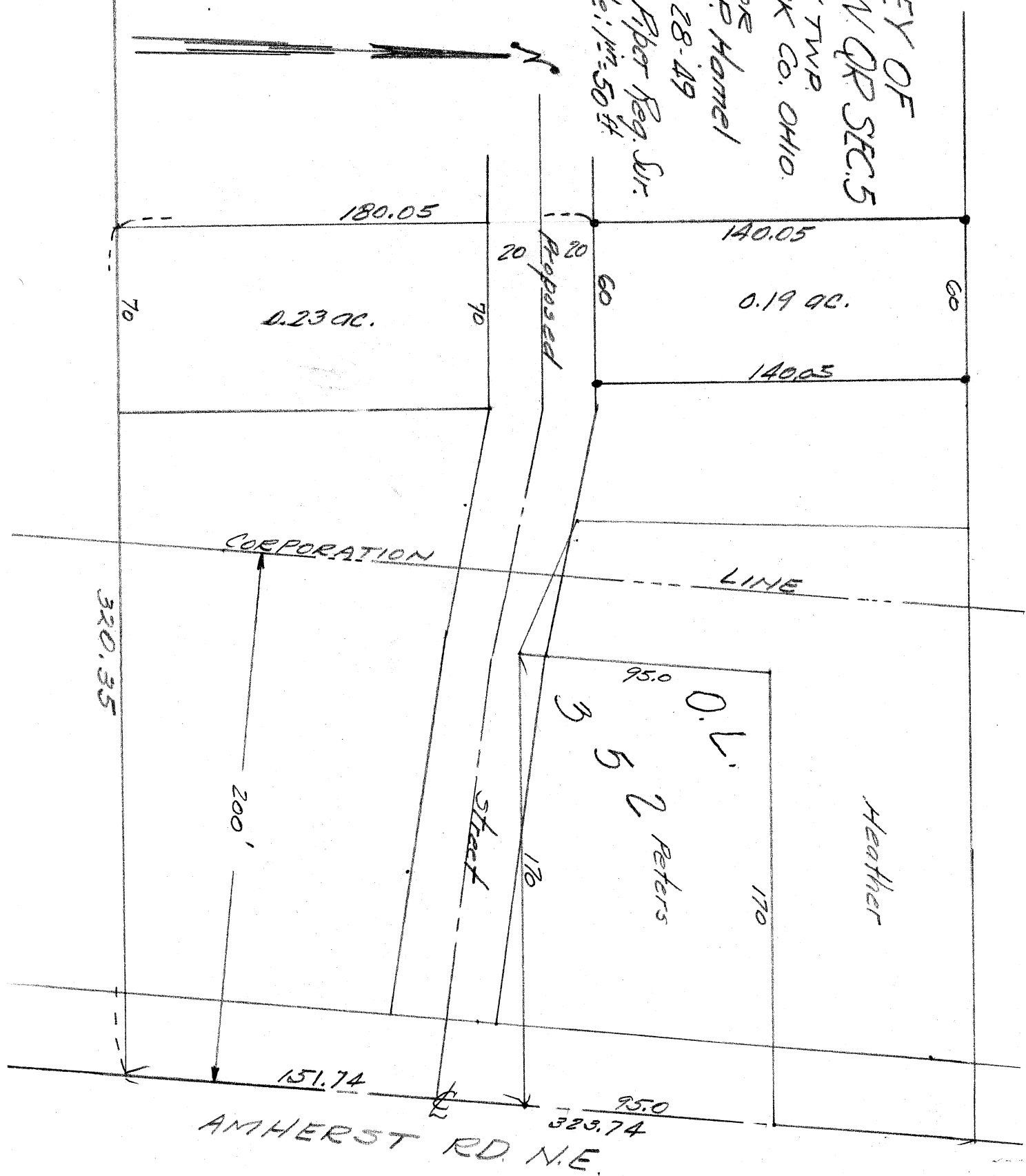

Known as a Pt. of O. L. 352 situated in the N.W. Qr. Sec. 5 Perry Twp., Stark County, Ohio and being more fully described as follows:

Beginning at the S. E. corner of O.L. 352 in the City of Massillon, Ohio, said point also being on the center line of Ashurst Rd. N.E.; thence westerly along the south line of O.L. 352, 320.95 feet to a stake; thence northerly at right angles to said south line 180.05 feet to a stake, said point being on the north line of a proposed street and also being the true place of beginning of the tract here-in to be conveyed; thence continuing northerly along the same line 140.05 feet to a stake on the north line of O.L. 352; thence easterly along the north line of O.L. 352 60.0 feet to a stake; thence southerly 140.05 feet at right angles to the south line of O.L. 352 said point being on the north line of a proposed 40 foot street; thence westerly 60.0 feet to the place of beginning containing 0.19 acres.
