

PARCEL NO. 1

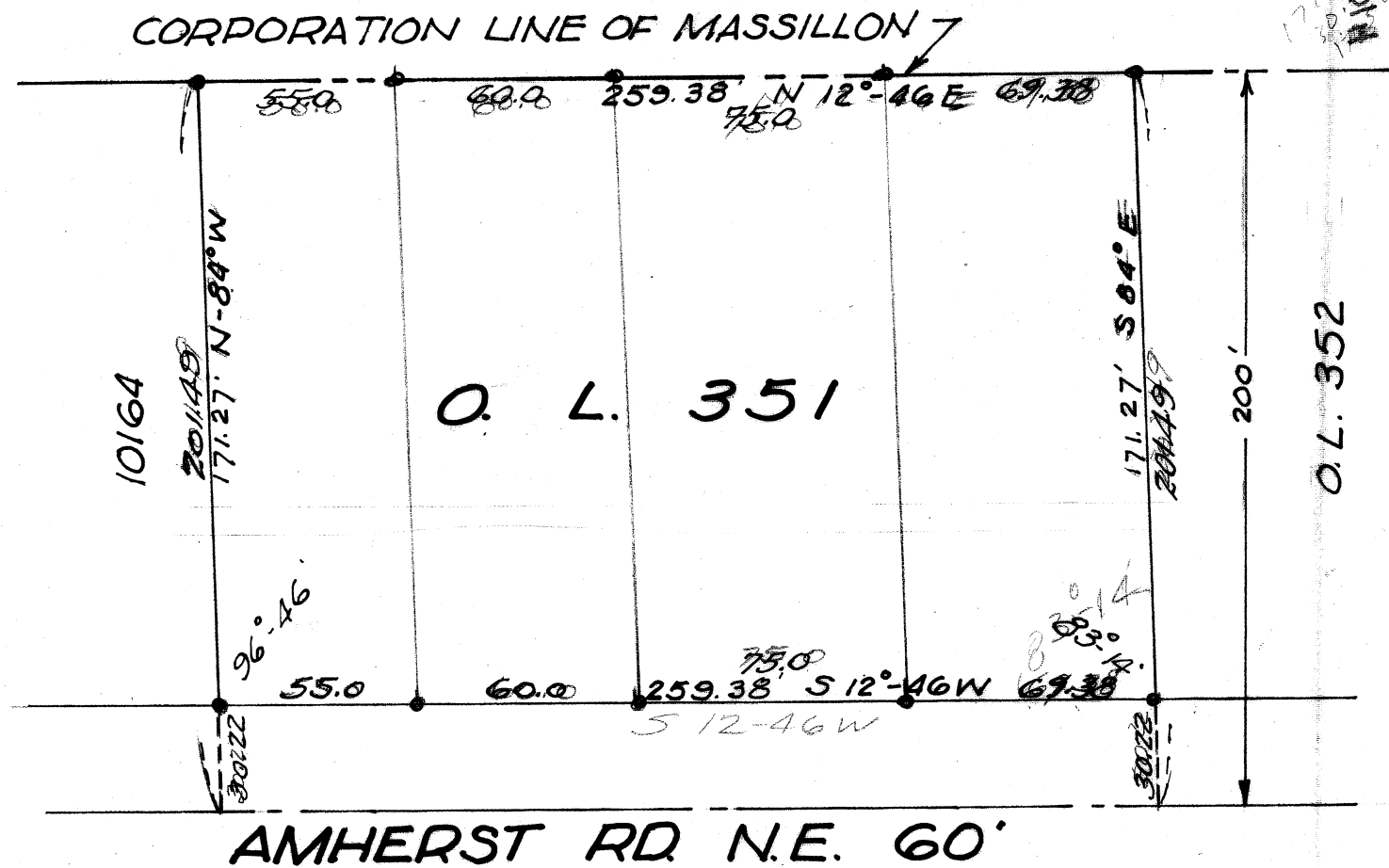
Known as and being a Part of O.L. 351 in the City of Massillon, Ohio, according to the present numbering of Lots in said City and being more fully described as follows:

E. 69.38 feet to an iron pin; thence N $84^{\circ}-0'$ W 171.27 feet to an iron pin; thence N $12^{\circ}-46'$ E 69.38 feet to an iron pin on the north line of O.L. 351; thence S $84^{\circ}-0'$ E along the north line of O.L. 351 171.27 feet to the place of beginning containing 0.27 acres.

Beginning at an iron pin on the west line of Amherst Rd. N. E. 69.38 feet south of its intersection with the north line of O.L. 351, said point being the true place of beginning of the parcel here-in described; thence continuing S $12^{\circ}-46'$ W along the west line of Amherst Rd. N. E. 75.0 feet to an iron pin; thence N $84^{\circ}-0'$ W 171.27 feet to an iron pin; thence N $12^{\circ}-46'$ E 75.0 feet to an iron pin; thence S $84^{\circ}-0'$ E 171.27 feet to the place of beginning containing 0.29 acres.
