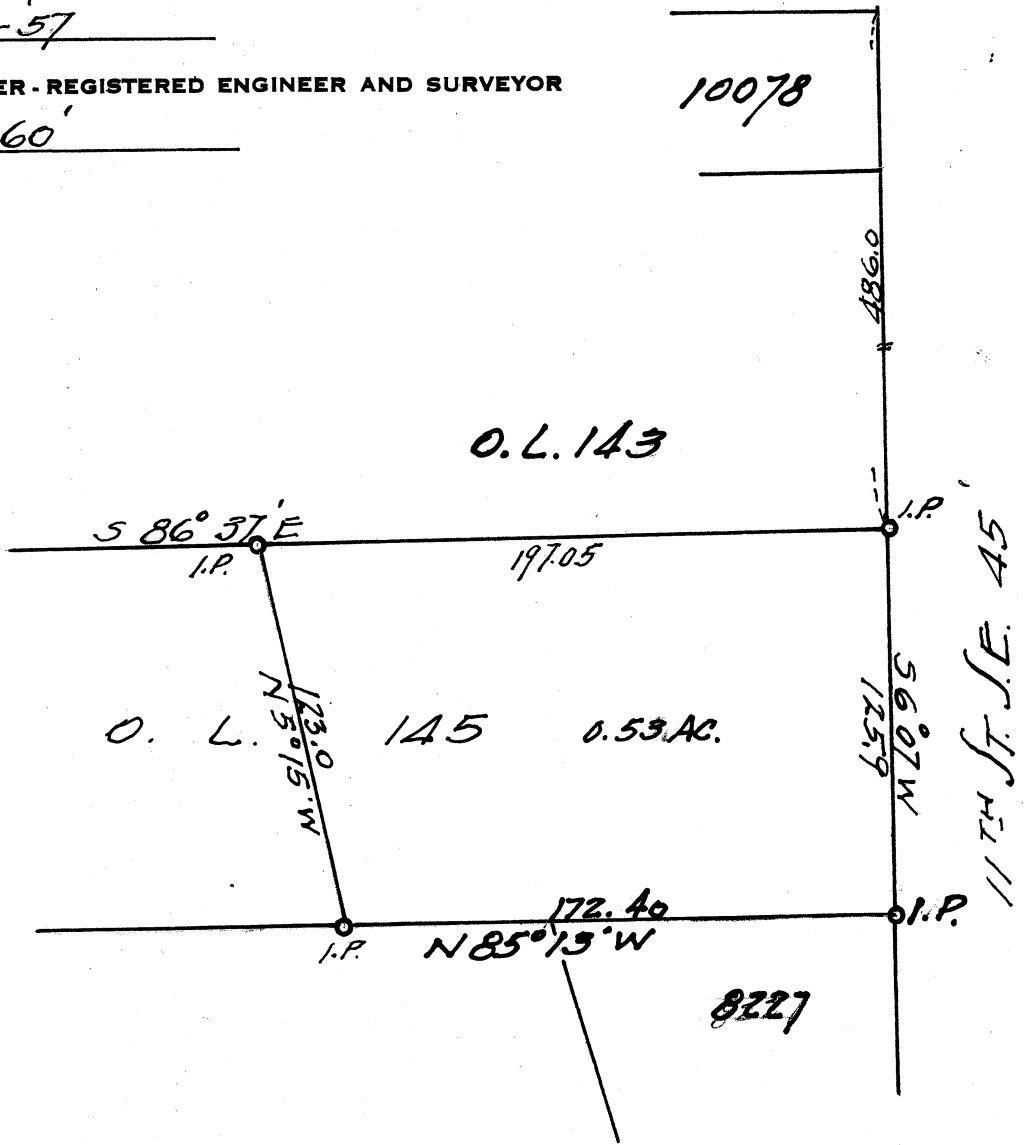

DESCRIPTION EAST PART O. L. 145

Being the East part of O. L. 145 in the City of Massillon, Ohio, according to the present numbering of Lots in said City, and being more fully described as follows:

Beginning at the N. E. Corner of Lot No. 10078 on the W. line of 11th St. S. E.; thence  $S6^{\circ}-07'W$  along the W line of 11th St. S. E. 486.0 feet to an I.Pin at the N. E. Corner of O. L. 145, said point being the true place of beginning of the tract here-in conveyed; thence continuing  $S6^{\circ}-07'W$  along the west line of 11th St. S. E. 125.90 feet to an I.Pin at the N. E. Corner of Lot No. 8227; thence  $N85^{\circ}-13'W$  172.40 feet along the S. line of O. L. 145 to an I.Pin; thence  $N5^{\circ}-15'E$  123.0 feet to an I.Pin on the S. line of O. L. 143; thence  $S86^{\circ}-37'E$  197.05 feet to the place of beginning containing 0.53 acres.

Description of a Tract of Land Surveyed for Jeremiah Kitchen  
January 4-5, 1915.

Being a part of Out lot No. One hundred forty-three of the City of Massillon, Stark County, Ohio, which is bounded and describe as follows:-

Beginning at an iron pin set in the centerline of North Mill St. of said city at a point South 22 degrees East 85 feet from the intersection of the center line of said Mill St. with the North line of Out Lot No. 143 and extending thence North 81 degrees East One Hundred sixty-three (163) feet to an iron pin, Thence South 9 degrees East fifty-three and six-tenths (53.6) feet to an iron pin; thence South 81 degrees West one-hundred fifty and five-tenths (150.5) feet to the center line of North Mill Street aforesaid; thence North 22 degrees West and along the center line of Mill Street, fifty-five (55) feet to the place of Beginning; containing nineteen hundredths acres of land more or less but subject to all legal highways.

Being a partt of Out Lot No. One Hundred - forty-three of the city of Massillon, County of Stark, State of Ohio; bounded and described as follows: -

Beginning at an iron pin set in the centerline of N. Mill Street of said city at a point South 22 degrees East 140 feet from the intersection of the center line of said North Mill Street with the north line of Out Lot No. 143 and extending thence North 81 degrees East 150.5 feet to an iron pin; thence South 9 degrees East 66.2' feet to an iron pin; thence South 89 degrees and 35 minutes West 141.6 feet to a point in the center line of North Mill Street; thence North 22 degrees West and along the center line of North Mill Street 46 feet to the place of beginning, . containing nineteen hundredths acres of land more or less but subject to all legal highways.
