

DESCRIPTION FOR PT. C.L. 207

MASILLON, TUSCARAWAS TWP., STARK COUNTY, OHIO

Being a Pt. of C.L. 207 in the City of Massillon, Tuscarawas Twp., Ohio, according to the present numbering of lots in said City and being more fully described as follows:

Beginning at the true place of beginning of the tract herein conveyed, said point being a stone monument at the N. W. corner of C.L. 207; thence easterly along the north line of C.L. 207 300.0 feet to an iron pin at the N. E. corner of C.L. 206; thence southerly along the west line of C.L. 206 59.4 feet to an iron pin; thence easterly along the south line of C.L. 206 470.0 feet to an iron pin in the centerline of 32nd St. N. W.; thence southerly along the centerline of said street 3.5 feet to a point; thence westerly 762.65 feet to an iron pin on the 1/ section line 70.0 feet south of the N. W. corner of C.L. 207; thence northerly along said 1/ section line 70.0 feet to the place of beginning containing 0.68 Acres of which 56.0 square feet is a part of 32nd St. N. W.

Massillon, Ohio



Known as and being a Pt. of O.L. 207 in the City of Massillon, Tuscarawas twp., Stark County, Ohio, according to the present numbering of lots in said City and being more fully described as follows:

Beginning at an iron pin at the centerline of 32nd St. N. W. and the North Corporation line; thence S $11^{\circ}0'W$ along the centerline of 32nd St. N. W. 106.5 feet to the true place of beginning of the tract herein conveyed; thence continuing S $11^{\circ}0'W$ 74.40 feet to a point; thence N $79^{\circ}25'W$ 215.0 feet to a point; thence N $11^{\circ}24'E$ 60.0 feet to a point; thence S $63^{\circ}10'E$ along the southline of the property conveyed to C. Baker 215.0 feet to the centerline of 32nd St. N. W. and the place of beginning containing 0.33 Acres.

Excepting a 15' strip of land off the entire east side of said tract for street purposes.
