

D E S C R I P T I O N

Lot No. 14119 & Pt. Lot No. 14116

Thence continuing S87°27'24"E, a distance of 242.80' to a point on the east line of said Lot No. 14116;

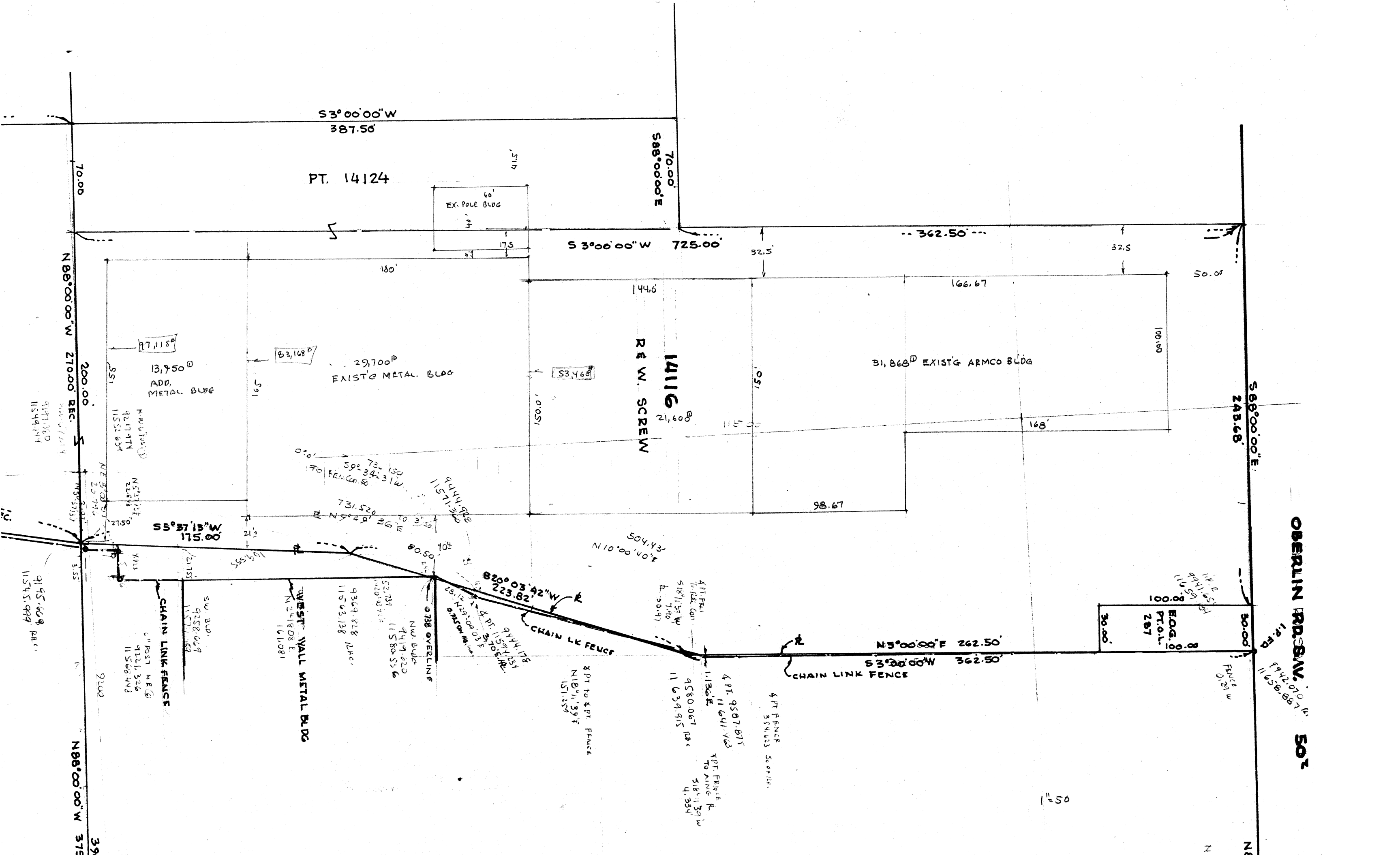
Thence S20°03'42"W along the said east line of Lot No. 14116, a distance of 118.67' to a point;

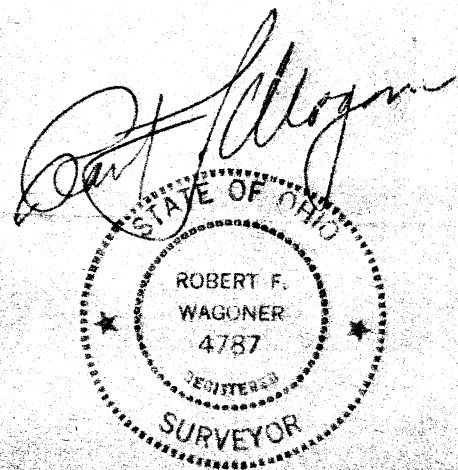
