PT. OF O.L. 424 CITY OF MASSILLON, STARK COUNTY, OHIO

Known as and being part of O.L. 424 in the City of Massillon, Stark County, Ohio and being more fully described as follows:

The true place of beginning being at the southeast corner of Lot No. 12526, said point being on the west line of said O.L. 424;

Thence N3°36°50"E along the west line of said 0.L. 424 a distance of 124.34° to a point;

Thence N74*23'00"E a distance of 161.22' to a point on the west line of porposed Tanglewood Dr., N.E.;

Thence on a curve to the left with a radius of 313.82', a delta of 13°41'40", an arc length of 75.00' and a chord distance of 74.82' bearing \$22°27'50"E to a point of reverse curve on the westerly line of said proposed Tanglewood Dr., N.E.;

Thence on a curve to the right with a radius of 25.00°, a delta of 81°30°50", an arc length of 35.57° and a chord distance of 32.64° bearing S11°26'50"W to a point of tangency on the northerly line of the extension of Colonial Parkway, N.E.;

Thence S52°12*20"W on the northerly line of the extension of Colonial Parkway, N.E. a distance of 29.69* to a point of curvature;

Thence on a curve to the right with a radius of 232.91, a delta of 42°23'10", an arc distance of 172.32', and a chord distance of 168.40' bearing 873°23'50"W to a point of tangency, said curve being along the northerly line of the extension of Colonial Parkway N.E.;

Thence N85°24*40"W along the extension of Colonial Parkway, N.E. a distance of 0.44* to the true place of beginning, containing 0.517 acres.

EASEMENT

Being a 50.00' easement, for Egress, Ingress and Ulitities, over part of 0.L. 424 which is the proposed extention of Colonial Parkway, N.E. Said easement being a strip of land laying 50.00' south and southeast of this line described herein: Beginning at the southeast corner of Lot No. 12526, thence S85°24'40"E a distance of 0.44'; thence on a curve to the left with a delta of 42°23'10", an arc distance of 172.32' and a chord distance of 168.40' bearing N73°23'50"E to a point of tangency; thence N52°12'20"E a distance of 29.69' to the end of said easement.

SANITARY SEWER EASEMENT
