Beginning at a three-quarter inch diameter iron pipe found at the northwest corner of said Lot Number 7479; thence S 85°37'00" E along the south line of Rotch Avenue N.E., a 60 foot public right-of-way, a distance of 75.00 feet to a one inch diameter iron pipe set and the true place of beginning for the tract of land herein described;

- 1) Thence continuing S 85°37'00" E along the south line of said Rotch Avenue N.E. a distance of 124.61 feet to a point of curvature, said point referenced by a three-quarter inch diameter iron pipe found at the point of intersection of said curve;
- 2) Thence along a curve to the right having a central angle of 91°07'00", a radius of 20.00 feet, and a tangent of 20.39 feet to a point of tangency with the west line of Wales Road N.E., a 60.00 foot public right-of-way; said point of tangency being referenced by a three-quarter inch diameter iron pipe found at the point of intersection of said curve:
- 3) Thence S 5°30'00" W along the west line of said Wales Road N.E., a distance of 76.61 feet to a three-quarter inch diameter iron pipe found at the southeast corner of said Lot Number 7479:
- 4) Thence N 85°37'00" W along the south line of said Lot Number 7479 a distance of 145.00 feet to a one inch diameter iron pipe set;
- 5) Thence N 5°30'00" E and going through said Lot Number 7479 a distance of 97.00 feet and returning to the true place of beginning.
