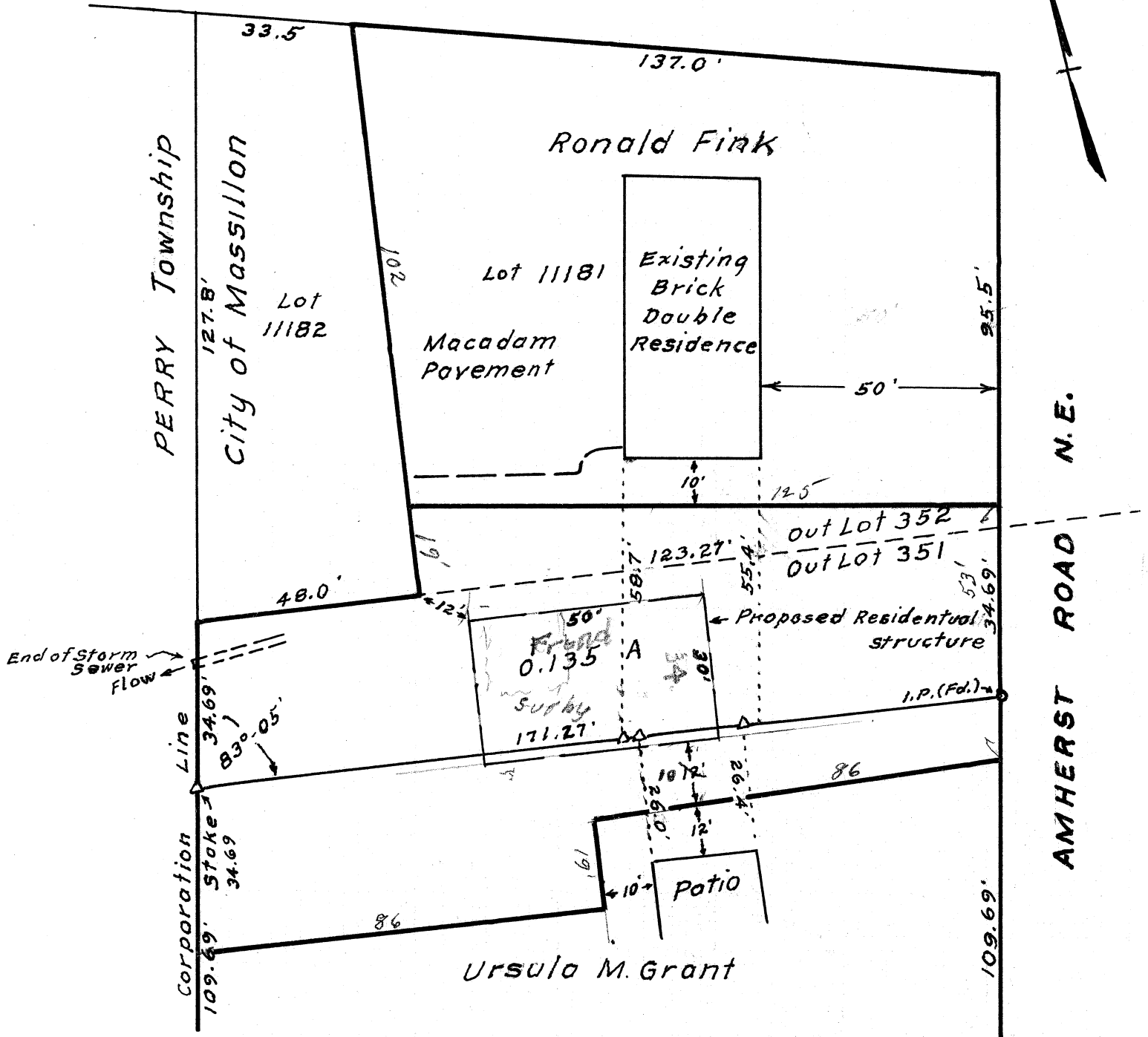
PROPERTY MAP

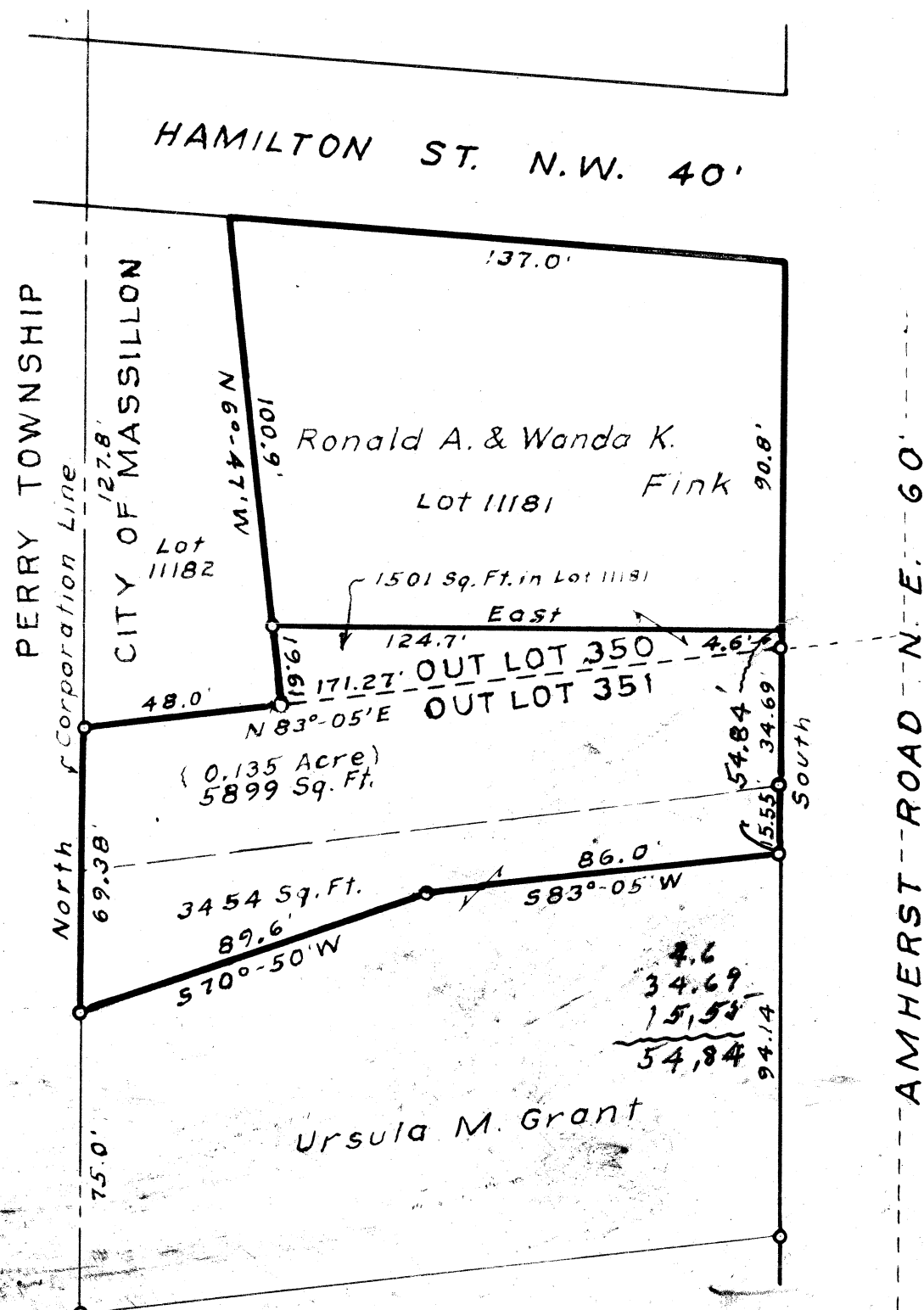


Map Showing North Property
