Known as and being Part of the Northwest Quarter Section 21, Perry Township, Part O.L. 559, Part O.L. 560, Part O.L. 561, & Part O.L. 566 in the City of Massillon, Stark County, Ohio, and being more fully described as follows:

The true place of beginning being an existing Stark County monument at the southwest corner of the Northwest Quarter Section 21, Perry Township;

Thence N1°40'48"E along the west line of said Northwest Quarter Section 21, a distance of 530.02' to an existing iron pin;

Thence S87°52'41"E along the north line of the property of the State of Ohio, a distance of 826.43' to an iron pin set;

Thence N1°49'43"E along the east line of a tract owned by C. & M. Sullivan as recorded in Vol. 3316, Page 350, a distance of 827.77' to an existing iron pin;

Thence S87°46'36"E along the south line of a tract presently owned by Pachan Construction as recorded in Vol. 3441, Page 377, and Blaumeister, Vol. 3582, Page 475, a distance of 680.19' to an existing iron pin;

Thence S1°49'43"W along the west line of a tract owned by the City of Massillon as recorded in Official Record Vol. 404, Page 810, a distance of 1354.28' to an existing iron pin on the Quarter Section line between Southwest Quarter Section 21 and Northwest Quarter Section 21; said line also being an Out Lot line between O.L. 559 and O.L. 561;

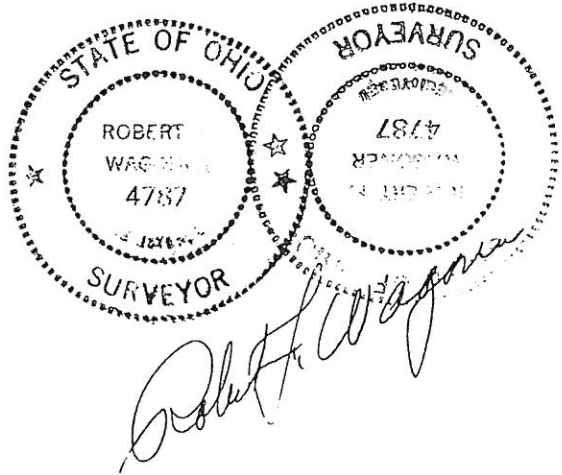
