## DESCRIPTION OF A 0.001 ACRE TRACT

Situated in the City of Massillon, County of Stark and State of Ohio and being part of Mssillon City Lot 10779 more fully bounded and described as follows to-wit:

Beginning at a 3/4" iron pipe found at the intersection of the line between Massillon City Lots 10779 and 10780 with the right-of-way line of Marlyn Parkway, a variable right-of-way, said iron pipe being the true place of beginning for the tract of land herein described;

- 1.) Thence S50°18'00"W coincident with the line between said Lots 10779 and 10780, a distance of 12.31 feet to a 1" iron pipe set;
- 2.) Thence N15°36'00"E, a distance of 16.53 feet to a 1" iron pipe set on the southwestern right-of-way line of said Marlyn Parkway;
- 3.) Thence coincident with the southwestern right-of-way of said Marlyn Parkway on a curve to the left having a central angle of 05°26'43", a radius of 100.00 feet, a tangent of 4.76 feet, a chord of 9.50 feet and a chord bearing of S31°55'40"E, a distance of 9.50 feet to a 3/4" iron pipe found and the true place of beginning.

Booth by a deed recorded in Volume 3353, page 603 Stark County Deed Records and contains 0.001 acres as surveyed by Ronald P. ## DESCRIPTION OF A 0.013 ACRE TRACT

Situated in the City of Massillon, County of Stark and State of Ohio and being part of Massillon City Lot 10780 more fully bounded and described as follows to-wit:

Beginning at a 3/4" iron pipe found at the intersection of the line between Massillon City Lots 10779 and 10780 with the right-of-way line of Marlyn Parkway, a variable right-of-way; thence S50°18'00"W coincident with the line between said lots 10779 and 10780, a distance of 12.31 feet to a 1" iron pipe set and the true place of beginning for the tract of land herein described;

- 1.) Thence S15°36'00"W, a distance of 54.65 feet to a 1" iron pipe set;
- 2.) Thence N84°14'00"W, a distance of 9.24 feet to a 1" iron pipe set on the line between Massillon City Lots 10779 and 10780;
- 3.) Thence NO5°18'00"E coincident with the line between said Lots 10779 and 10780, a distance of 34.68 feet to a 5/8" iron pipe found 2' deep:
- 4.) Thence N50°18'00"E coincident with the line between said Lots 10779 and 10780, a distance of 26.89 feet to a 1" iron pipe set and the true place of beginning.
