Beginning for reference at a 1/2" pipe found at the southwest corner of Lot #9387 in the present numeration of the City of Massillon and being the True Place of Beginning of the tract herein described; thence

N 75°28'20" E 174.00 feet along the south line of Lot #9387 to a rebar set; thence continuing along the south line of Lot #9387

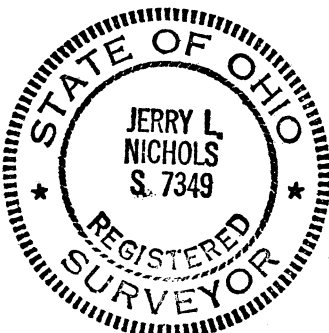
N 79°27'20" E 166.00 feet to a rebar set on the west line of Lot #9392 and the east Out Lot line; thence

S 19°15'00" E 19.63 feet along the line between Lot #9392 and Out Lot 53 to a rebar set; thence

S 70°35'21" W 337.50' parallel to Highland Avenue S.E. to a rebar set on the west Out Lot line and east right-of-way of 3rd Street S.E. (60' right-of-way); thence

N 19°15'00" W 60.03 feet along said west Out Lot line and east right-of-way of 3rd Street S.E. to the True Point of Beginning.

The above described tract contains 0.332 Acres or 14,445 square feet of land as surveyed by Nichols Field Services, Inc. in August 1993 under the supervision of Jerry L. Nichols Registered Professional Surveyor #7349 and is subject to all legal highways and easements of record. All rebars set are #5, 30" long and bear a cap imprinted Nichols 7349. The basis of bearings for this document is the east line of Out Lot 53 as recorded in O.R. 1363 Pg 612.

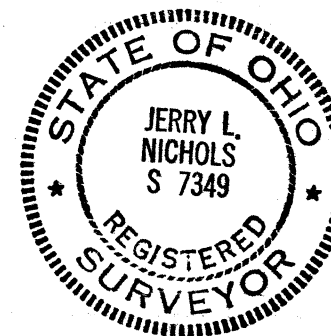
